The traces of human nature are steadily manifesting despite the continuously changing world and exponentially growing technological progress. History repeats itself. Can we learn enough from it? This also concerns to the education of future generations, not only in relation to using modern technology, but also regarding the recognition of basic principles that guide our lives. There is a social and civilization need for a return to philosophical questions of good, truth, responsibility, hope, dignity – not only in their epistemological and ontological dimensions, but also in the context of ethical, social, legal and environmental challenges of the contemporary world. The congress aims to provide a broad interdisciplinary space for a discussion about the current development and fate of humanity.





Thematic sessions

The history of the Institute of Philosophy Slovak Academy of Sciences, public research institution and generational impulses in Slovak philosophical thought

The session invites contributions that commemorate the 80. anniversary of the Institute (1946) and enrich perspective on its institutional formation not only through foreign influence but mainly through internal dimensions and the development of Slovak philosophical thought. The contributions might reflect on the institutionalisation of philosophy during the turbulent period of 50. and 60., the normalisation following 1968, and the pluralisation of philosophical views following 1989. We encourage contributions focusing on the analysis of the generational dynamics and relations between thinkers, who formed Slovak philosophical thought – ranging from personal ties and mentor relations to ideological tensions and controversies. We welcome contributions that overcome the dichotomy between collective responsibility attributed to certain generations of philosophers and indiscriminate optimism. The contributions can reflect on the Institute of Philosophy as a creative environment and a philosophical school in the CEE context, analyse works of important figures through the prism of generational affinity (K. Mannheim, J. Ortega y Gasset, and more), or critically examine methodological approaches employed in the Slovak philosophy in 20th century.

2. Philosophy-Ideology-Manipulation

Philosophy, religion, and science are (as many times in the past, so today) transformed into ideology and misused to manipulate and follow power ambitions. Is there a demarcation line between philosophy and ideology? Which factors cause the academic reflection to turn into a tool for manipulation? Can philosophy defend itself and protect the values of democracy, freedom, and humanity? How does technology, but also practices and policies influence our freedom and autonomy (stressing the importance of surveillance, control over information and manipulation)?

3. Environmental philosophy, critical environmentalism, and care of the world

The session focuses on a critical reflection of global risks and challenges of the Anthropocene from the perspective of pervasive global capitalism and its core imperatives that produce structural social and environmental injustice and that conflict with sustainable development of human civilisation. We need to rethink environmental, ethical, social, and political consequences of climate change on the global industrial civilisation and the impact of technologies on the modern natural world. How can technology help or harm our efforts for a sustainable future? Can the technological and digital progress succeed and at the same time ignore our biological and natural conditions? The ethics of care can complement and enrich contemporary intellectual challenges that centre around the place of the human in the world and the nature of our current condition.

4. Nature and/or construction: philosophical perspectives

The talks in this session will focus on the tension and a possible complementarity between naturalistic and constructivist approaches in the contemporary philosophy. The question of the degree to which we can understand he common starting point. To what extent can knowledge, normativity, or reality be understood as naturally given, and to what extent as a product of an active construction? This question will provide a common starting point. The session will also create space for a critical reflection of metaphilosophical assumptions of both approaches and connections between the two.

5. Teaching philosophy, teaching through philosophy

Philosophy considerably contributes to the formation of processes of education. The questions of the scope of its innovativeness and distinctness and the scope of its ties to traditional forms of education form another creative space at the Congress. These challenges relate to anyone who teaches philosophy (not only) in the academic setting, but also to anyone who teaches through philosophy. Apart from exploring the dialogical nature of philosophy, a space opens for a critical reflection of the scope and content of philosophical knowledge as taught in the high-school setting.

6.Rethinking traditional philosophical categories and notions in the context of current philosophical, scientific, societal, ethical, political, and legal challenges:

6a) Historico-philosophical reflections of traditional philosophical questions such as good, truth, responsibility, and beauty in the context of current thought and civilisation;

6b) Emancipatory and explanatory role of social sciences and humanities in dealing with the challenges of current civilisation;

6c) Technologies, digitalisation, and human existence: analysis of the impact of technologies on basic aspects of human existence (including our ability to create, communicate, and feel emotions);

Philosophical dimension of a fair distribution of technological resources and access to digital technologies.

7. Biopolitics and development of emergent technologies

Emergent technologies can substantially modify basic life processes, regulate life of individuals and human population alike. The progress in geneediting, pre-implanting genetical diagnostic, regenerative medicine, or neurobiology allows for optimisation of living organisms. This is connected to gradual change and configuration of social and political practices. Strategies are currently employed to eliminate genetic risks, to increase prevention, to introduce public health politics, and more. We invite contributions that will examine and reflect on the impact of the current bio-technological development on new bio-political strategies. The broader framework for analysis consists of relations between bio-scientific knowledge, technological innovations, and politics in the context of societal responsibility.

8.WORKSHOP: Artificial intelligence, achievements, and responsibility

The workshop focuses on AI responsibility gaps (situations when an AI system causes X and someone should be responsible for X, but no one is). The special focus will be on AI achievement gaps (situations when AI seemingly achieves something, and someone should be praiseworthy for this achievement, but no one is). The workshop is open to other topics related to responsibility gaps.
